- 6) The undersigned hereby agrees that any disputes arising out of this agreement or goods and merchandise ordered or delivered pursuant hereto will be governed and settled under applicable principles of Maryland law, under jurisdiction of Maryland courts.
- 7) Customer hereby agrees that Gilah Press + Design shall reserve the right to file any and all required documents to secure its interest in goods under the provisions of article 9 of the uniform commercial code.
- 8) Customer agrees by applying for credit, should account be paid beyond thirty days, account is in default and breach of contract.
